Policy

- No refunds on any rentals returned unused.
- Cancellations of reserved equipment will not be refunded.
- Gear not returned clean will be charged a \$10 cleaning fee. Rinse everything with cold, fresh water.
- Gear returned with damages will be charged applicable fees.
- Regulators returned with missing clips will be charged a \$15 fee.

Agreement and Release Liability

- I am aware that SCUBA or Skin Diving is a hazardous activity with an inherent risk. I am voluntarily participating in these activities with full knowledge of the dangers involved and agree to accept all risks of loss, injury or death.
- I have inspected the equipment I am renting and agree it is in correct working condition and that I understand the proper use of the equipment.
- I understand that I will be charged a \$25 fee for each tank returned under 300 PSI.
